Greetings!

With planting season gearing up and Extension meeting season wearing down, I am going to combine the March and April newsletters into one. Therefore, barring any information emergencies, you won't hear from me, on paper anyway, until May. In the meantime, I will continue to keep the Extension website and Facebook page updated, so check back often!

Just a few notes for this month and next...

For those interested in helping maintain our **pollinator populations**, funding through the USDA may be available. Money is available through the EQIP program to fund conservation practices that provide safe and diverse food sources for honey bees while protecting the environment. The **sign-up deadline is March 21st**. More information on the program can be found at http://www.nrcs.usda.gov/wps/portal/nrcs/detail/wi/home/?cid=nrcs142p2_020742.

Winter weather interfered with our plans, and so the **Shawano County Forage Council Annual Meeting is rescheduled for March 27th**. The agenda and registration form can be found inside. The meeting is an excellent opportunity to hear from a farmer who has used cover crops, livestock and conservation practices to improve soil health on his farm.

If you are still debating your cropping strategy this year, remember the **2014 Crop Budget Cost of Production Calculator** is available for download at <http://www.uwex.edu/ces/farmteam/>. Look in the Enterprise Budgets heading and then go to the Field Crop section. Although no one has a crystal ball, the latest (February 21, 2014) USDA Grains and Oilseeds Outlook is less optimistic than the last—http://www.usda.gov/oce/forum/2014_Speeches/Grains_Oilseeds.pdf. The February 2014 Livestock, Dairy and Poultry Outlook can be accessed here <http://www.ers.usda.gov/ersDownloadHandler.aspx?file=/media/1280524/ldpm236.pdf>.

If you are contemplating which forage to plant this spring or if you would like to brush up on the latest techniques and research on alfalfa, I encourage you to visit the **UW-Extension Team Forage website**: <http://www.uwex.edu/ces/crops/uwforage/uwforage.htm>. The webpage will be transitioning to a new URL shortly, but the address I provided will redirect you to the new site.

The results of the **2013 winter wheat fungicide trials** are now available at <http://fyi.uwex.edu/fieldcroppathology/wheat/2013winterwheatfungicide/>. The study concluded that...“Application of fungicide at emerging flag leaf was the best application timing to control leaf blotch disease, which resulted in a significant improvement in yield.”

By now, you have likely heard that spring 4-H and FFA swine weigh-ins have been banned in an effort to limit the spread of **Porcine Epidemic Diarrhea Virus (PEDV)**. This deadly, highly communicable disease is estimated to have killed over 4 million piglets nationwide and confirmed cases are on the rise. Practicing strict biosecurity protocols on all swine farms is key to limiting the spread of the disease. You can learn more about PEDV by visiting the American Association of Swine Veterinarians website (<http://www.aasv.org>). *Please help to educate the public that PEDV is not transmissible to humans and that pork remains safe to eat.*

As more information about the new **Farm Bill** programs becomes available, UW-Extension will be hosting informational sessions on how the new crop, livestock and dairy programs can work for you. I will send you details about these sessions as soon as I receive them, but much like you, we are waiting patiently to learn more about program specifics and sign ups.

The status of the **Implements of Husbandry** bill is still up in the air (at least as I am writing this). At press time, a bill, AB842, had been introduced to establish an 18-month moratorium on the enforcement of weight limits against large agricultural equipment.

Remind your favorite high school and college students to **apply for local agricultural scholarships**, such as the Shawano County Forage Council scholarships (due May 1, <http://shawano.uwex.edu/agriculture/foragecouncil/>), Shawano County Farm Bureau scholarships (due April 1, <http://wfbf.com/countyfarmbureaus/shawano/>), and the Shawano County Farm Progress Days scholarships (due April 15, <http://shawano.uwex.edu/agriculture/youth/>).

Questions regarding the **EPA Spill Prevention, Control and Countermeasure rule (SPCC)** for farms have been coming into county offices. The link to the EPA website and information can be found here http://www.epa.gov/osweroe1/content/spcc/spcc_ag.htm. There is a self-certification template that, depending on the quantity of reportable substances you have on your farm, may work for you. The farm factsheet on the above website discusses the criteria farms must meet to need the SPCC plan.

Additionally, UW Extension is offering **classes for woodland owners**. The Green Bay classes will be held at the Ag & Extension Service Center, 1150 Bellevue Street from 6 pm – 8 pm as follows: Session 2 – Introduction to Timber Harvesting and Sales – Thursday, March 27, 2014; Session 3 – Keeping Your Woods Healthy: The Signs and Symptoms of Sick Trees – Thursday, April 10, 2014; and Session 4 – Get to Know Your Local Trees and Invasive Plants – Thursday, May 1, 2014. 
